## New Business

- f. Streetlights in front are not maintained by Gulf Power. Heidi Jonquist suggested finding out how to bring the lights up to code and what would be required to have Gulf Power maintain them. Dale discussed how to report other streetlight issues and instructions to be provided in next newsletter
- g. Trail Maintenance Would like to obtain estimates for repairs. Will put request for concrete contractors on Facebook page for recommendations. Dale to ask Patrick (neighborhood lawn maintenance provider) to cut back tree overhang on trail.

- h. Amending Covenants, the following are just a few items that need to be brought up to date:
  - (i) to allow wood-look fencing of other materials (vinyl, metal, etc.)
  - (ii) To state that state laws override our bylaws
  - (iii) Clarify some vague items
  - (iv) Change number of people who can vote
- Security There was some conversation last year on social media regarding residents wanting to see if we could have security cameras placed at the front to address at Annual Meeting
- j. Storage Unit Discussion about what was stored in there and where it was located. Heidi Jongquist suggested scanning in old documents stored there to have digitally available to save storage room.
